### **Wihlborgs conducts share split**

**The Annual General Meeting of Wihlborgs Fastigheter AB (publ), held on 26 April 2022, resolved on a two-for-one division of the company's shares (a "split"), by which each old share will be replaced with two new shares. The Board was authorised to establish a record date for the split.**

The Board has decided that the record date for the split is 24 May 2022 and the new shares are expected to be registered in shareholders' accounts on 25 May 2022.

The last day of trading in shares before the split is 20 May 2022 and the first day of trading in shares after the split is 23 May 2022. The new ISIN code for the share will be SE0018012635.

The split will be carried out automatically through Euroclear Sweden AB and shareholders are not required to take any action.

The split means the number of shares in Wihlborgs Fastigheter AB (publ) will increase from 153,713,456 to 307,426,912.
